Dear [Recipient Name/Clerk of the Court],

I am writing to formally respond to the allegations filed against me and to document a persistent pattern of harassment by my neighbor at 112 Orono Street, Clifton, NJ. I believe the recent complaint against me is frivolous, unfounded, and intended to disparage my family.

Regarding the allegations of mail tampering, I have never interfered with the complainant's mail. Any contact I have had with her mail occurred only when the postal carrier mistakenly placed it in my mailbox. Her mailbox was never label. In those instances, I simply placed the items on top of her box or outside of mine to ensure they reached her.

I would also like to document several incidents of ongoing harassment and intimidation directed at my family:

- Verbal Threats and Provocation: The complainant has made repeated verbal threats of physical violence against me and my daughter, Marcela Rosado. We have also documented instances where she attempted to provoke us into verbal altercations, including an incident where she taunted my daughter while standing behind her husband, Johan Hernandez.
- Harassment via Authorities: She has repeatedly called the police with unfounded claims, including contacting animal control regarding my two small dogs for barking while she was positioned in the shared hallway.
- Noise Disturbances: Throughout October 2025, the complainant and her daughter, Jasmine Henao, placed speakers in the hallway to disturb me while I worked remotely. The police were called and advised that a summons would be issued if the behavior continued. She also consistently creates loud disturbances during late-night hours.
- December 22, 2025 Incident: On this date, Johan Hernandez came to my door to threaten me regarding a court case. During the ensuing interaction, Roseanne Silva also directed verbal abuse at me while attempting to stay out of view of my security camera. Although my daughter was the first to call the police, the responding officers were dismissive of our side of the story. We were promised a link to provide a formal statement, which we never received despite providing our contact information multiple times.

Furthermore, we believe the complainant is attempting to pin criminal charges on us to force our removal, a tactic we understand she has used against previous neighbors. We have installed security cameras for our protection and have captured footage of her stating her intent to file lawsuits. We also have evidence of her husband and daughter accessing our mailbox to remove legal documents, including a summons we never officially received.

My son-in-law, Ivan D. Ortiz, and I are college-educated professionals who have lived at this address without any history of conflict with other neighbors. We are filing this report to ensure there is a formal record of the truth regarding these interactions.
