NARRATIVE

On Monday, December 22, 2025, at 1849 hours, I, Officer Tello (Car 6D), along with Officers DeGroat and Rojas (Car 10D), were dispatched to 112 Orono Street regarding a dispute over a package involving the occupants of the first and second floors.

Upon arrival, I spoke with the caller and complainant, Roseana Henao, who reported that on this date, 12/22/2025, her first-floor neighbor, later identified as Elisa Romera, picked up her Amazon package containing glass items and threw it onto the floor outside the front porch of the residence. Roseana stated that there was no damage to her package. However, she indicated this is an ongoing issue she has been experiencing with Elisa. In the past, Elisa has been looking through Roseana's mailbox, grabbing packages addressed to her, and throwing them on the ground. Roseana also reported theft of mail, which she previously reported to the Clifton Police Department under case number 25-075666 (see incident report for further details).

Roseana informed us that she has spoken to her husband, Anthony Sandoval, about the incident, and he went to speak with Elisa. Anthony stated he wanted to have a calm conversation with her; however, her daughter, Marcela Rosado, became loud and uncooperative once he mentioned the possibility of filing charges. They expressed a desire to keep the peace and requested police assistance.

An Axon Link community request was sent to Roseana's phone, requesting any available video surveillance footage and photographs related to this incident.

Officers DeGroat and Rojas spoke with Elisa Romera, who stated that she checked for a package, observed that it was not addressed to her, and then tossed the package back onto the porch. Anthony then responded to her side entrance, where her daughter, Marcela Rosado, answered the door. Anthony wanted to speak with Marcela's mother, Elisa, but she was not allowing him to, and they exchanged words back and forth.

Roseana and Elisa were informed of the complaint signing procedure, and they acknowledged understanding.

Roseana also stated that she was in the process of filing a complaint regarding a previous incident but decided not to proceed at that time to give Elisa the benefit of the doubt.

A check for wants, warrants, and Domestic Violence Registry status for both Roseana and Elisa yielded negative results.

Roseana was provided with an incident card containing the case number for her records.
