On 11/19/2025 at approximately 0930 hours, while assigned to the front desk, I was approached by a female party later identified as Ms. Roseana Henao who wanted to file a report of theft of mail.

Roseana stated that she lives on the second floor at 112 Orono St and stated that the incident of stolen mail has been ongoing since April 6 2025 at approximately 1304 hours with the first-floor tenant and stated that she previously spoke with her landlord (no pedigree information provided) pertaining to this incident.
